Waiver and Release

I hereby acknowledge and agree that I have read this waver and release, that I fully understand same, and that I am freely and voluntarily executing same. By signing this waver and release I will be forever prevented from suing or otherwise claiming against the releases for any property loss or personal injury that I may sustain while and/or participating in any activities involving the above noted club or land owner.

I acknowledge that I am informed and understand both the major (up to and including death) and minor hazards and risks associated with my membership, participation and/or attendance. I understand, accept and assume those hazards and risks of off road recreation. Therefore, I have determined whether I have adequate separate personal insurance to cover all harm that my family or I may suffer due to attendance or participation in any club related activity and I have personally obtained all insurance protection that I want.

I understand that I will not be permitted to become a member of the above noted club unless I sign this waver and release.

I HAVE READ AND UNDERSTAND THIS WAIVER AND RELEASE AND I AM AWARE THAT BY SIGNING THIS WAVER AND RELEASE I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASES.
